for Supporting Medicare Advantage

This year, the Coalition for Medicare Choices (CMC) expressed our appreciation for Members of Congress who [protected and strengthened the Medicare Advantage program](#) during this year's rate notice period. Coalition members mobilized to show their gratitude for the Congressional leaders who continue to support Medicare Advantage and the nearly 30 million Americans who rely on the program.

- **Over 50 Medicare Advantage Champion Awards delivered** in-person to Members of Congress by CMC's Coalition members
- **26 earned media hits**, of which 19 are original copy, with a reach of **27.5 million**
- **44 “thank you” social media posts** from Coalition members and grasstops advocates
- 10 Members of Congress published **18 tweets and public statements** about their Awards
- **Over 51,000 “thank you” emails** to Congressional champions and the White House
- Home-page takeovers executed in **13 local online news outlets** thanking 15 Congressional champions, reaching an audience of over **3.5 million**
- **Advertising among Beltway audiences** on Facebook, Instagram, news publication websites, and a home-page takeover of the Washington Post drove nearly **44 million impressions and 39,000 clicks**

Coalition members who depend on their Medicare Advantage coverage to access fitness classes and stay connected with their peers. News coverage of the event by *WMBC-TV*, a news station that airs in New Jersey, New York and Connecticut, had an audience reach of 6.8 million.

Coalition member Mark wrote in the [Miami Herald](#) to share his satisfaction with Medicare Advantage and his gratitude to his Member of Congress for protecting the program. He said, "**Whether an individual needs integrated hearing, vision and dental screenings and care, mental health services, wellness programs and gym memberships, telehealth services, home delivered meals or companion care programs, Medicare Advantage really does have it all available to beneficiaries.** [...] I was very grateful to see many of Florida's representatives, including **Congressman Carlos Gimenez**, recently sign on to a support letter for Medicare Advantage in the House."
