



78% of senior voters with Medicare Advantage are concerned about cuts to their benefits due to rising inflation rates.




Medicare Advantage delivers affordable coverage by reducing Medicare's cost-sharing and offering additional benefits that FFS Medicare doesn't cover, including a cap on out-of-pocket costs. And most plans offer additional benefits such as prescription drug coverage, comprehensive dental, vision, and hearing coverage, wellness programs, caregiver support, and innovative telehealth options.



In 2024, the average monthly Medicare Advantage premium is expected to be **\$18.50**.



99% of Medicare Advantage eligible Americans have access to Medicare Advantage plans that include comprehensive prescription drug coverage with zero premium (beyond the Part B premium).




The Medicare Advantage model can also help sustain FFS Medicare.


